Dear Attorney General Nessel,

1. This is in regards to AG file **2021-0321333A** June 4, 2021: AG DANA NESSEL 2021:

"Many of the concerns (**CRIMES?**) you express are the result of state legislation. The Attorney General cannot change these laws. Rather, the Attorney General is dutybound to enforce the laws that have been enacted by the Legislature. Therefore, I **suggest you contact your state representative or senator...**

2. Requests to Michigan senators and representatives for legislation and investigation were made.

3. I am a crime victim www.judicialcriminal.com and formally demand Michigan void a non-consented or client signature "settlement agreement"/judgments (3)-an original and 2 amendments.

"This first-in-the-nation initiative is established to provide justice to parents and families whose rights have been violated. In Florida, parental rights are reserved to the parent of a minor child without obstruction or interference from the state, any of its political subdivisions, governmental entities, or institutions."

Criminal cases will be forwarded to the Office of Statewide Prosecution.

5. Arizona state lawmakers are investigating allegations of ongoing abuse within Arizona's family court system through a series of joint ad hoc committee hearings.

On April 14, 2025: Senator Finchem stated:

"A judge cannot order whatever they would like. They are required to uphold the rule of law."

6. Michigan May 11, 1999: Macomb County Circuit Court, Chief Judge Maceroni:

MACERONI: Consent judgment of annulment, what is your issue regarding it?

CHRISTINE: The validity of it. I never consented or signed that, and neither did my attorney.

MACERONI: Your attorney did.

CHRISTINE: He said to form only, not content (rights).

MACERONI: Ms. Morrison, you are objecting to items that have been entered almost two years ago, and that's entitled to consent Judgment of Annulment.

CHRISTINE: Not without a signature.

MACERONI: That was approved as to form only (not the content of rights), and as far as Mr. Aiello was concerned and signed by Mr. Perakis, and if there was any problem with that, it should have been appealed a long time ago.

CHRISTINE: I never consented.

Michigan August 22, 2001: Judge Templin, Oakland County Circuit Court, Lawyer Malpractice Trial of Christopher Aiello:

LAWYER PERAKIS: (drafted a one-sided NON-CONSENTED settlement, testifying)

"Because Mr. Aiello (lawyer) has made prior errors, which precluded her from having visitation with her daughter... She couldn't be with her daughter, that's it exactly."

7. The Court Has a Responsibility to Correct a Void Judgment: The statute of limitations does not apply to a suit in equity to vacate a void judgment. (Cadenasso v. Bank of Italy, p. 569; Estate of Pusey, 180 Cal. 368, 374 [181 P. 648].) This rule holds as to all void judgments. In the other two cases cited, People v. Massengale and In re Sandel, the courts confirmed the judicial power and responsibility to correct void judgments.

The law is well-settled that a void order or judgement is void even before reversal", VALLEY v. NORTHERN FIRE & MARINE INS. CO., 254 U.S. 348, 41 S. Ct. 116 (1920) "Courts are constituted by authority and they cannot go beyond that power delegated to them. If they act beyond that authority, and certainly in contravention of it, their judgements and orders are regarded as nullities; they are not voidable, but simply void, and this even prior to reversal." WILLIAMSON v. BERRY, 8 HOW. 945, 540 12 L. Ed. 1170, 1189 (1850).

A void judgment is a nullity from the beginning and is attended by none of the consequences of a valid judgment. It is entitled to no respect whatsoever because it does not affect, impair, or create legal rights." Ex parte Seidel, 39 S.W.3d 221, 225 (Tex.Crim. App. 2001), Ex parte Spaulding, 687 S.W.2d at 745 (Teague, J.concuning).

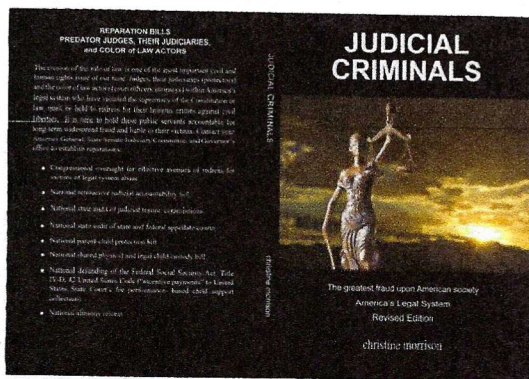
Therefore, as a crime victim Michigan can create an Office of Parental Rights with criminal cases forwarded to the Office of Statewide Prosecution.

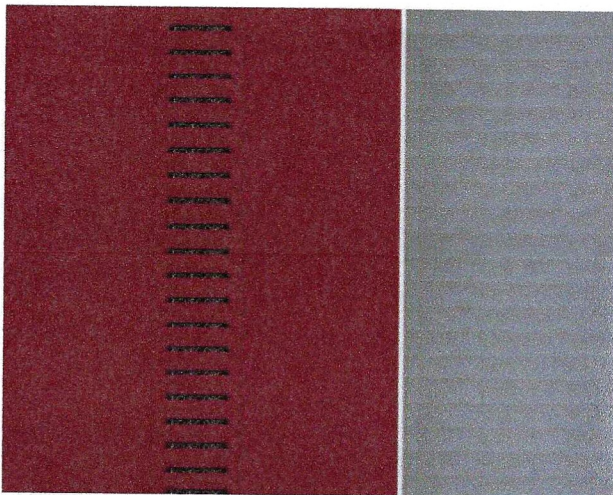


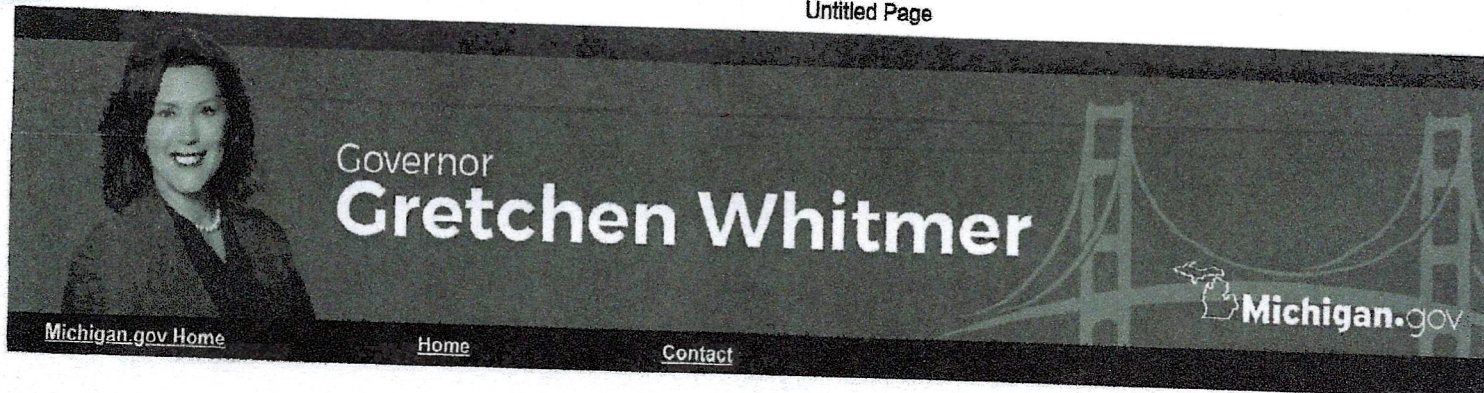
